Historic Preservation Fund – Competitive Grant Programs

## ■ African American Civil Rights (AACR) *Due Dec. 1, 2021*

Grants to document, interpret, and preserve sites and stories related to the African American Civil Rights movement and sites of the transatlantic slave trade. Projects types include National Register (or eligible) site preservation (\$75 - \$500K), and history projects (\$15 - \$50K) to include collections). #### ■ History of Equal Rights (HER) *Due Dec. 14, 2021*

Grants (\$75 - \$500K) to preserve National Register (or eligible) sites related to the struggle for equal rights. These grants are not limited to any specific group and are intended to include the broadest possible interpretation of sites associated with efforts to achieve equal rights. ### ■ Save America's Treasures (SAT) *Due Dec. 14, 2021*

Established as part of the millennium for the preservation and conservation (\$125 - \$500K) of nationally significant National Register buildings/sites and nationally significant collections (\$25 - \$500K) in partnership with NEA, NEH, and IMLS. 1:1 nonfederal match required. <a href="https://go.nps.gov/sat">https://go.nps.gov/sat</a>

### ■ Underrepresented Communities (URC) *Due Jan. 11, 2022*

Funds to survey historic properties associated with underrepresented communities, as well as nominations to the National Register for specific sites (\$25 - \$50K). No match required. https://go.nps.gov/urc

#### ■ Tribal Heritage Grants (THG) NOFO to be posted Dec 2021/Due early 2022

Grants to Indian, Alaskan Native, and Native Hawaiian communities to assist in protecting and promoting unique cultural heritage and traditions. Projects include: oral histories, survey and inventory, preservation planning, education, interpretation (\$15 - \$50K), and National Register site preservation (\$15 - \$65K). - Historically Black Colleges and Universities (HBCU) NOFO to be posted Dec 2021/Due early 2022 Grants (\$50 \$500κ), to assist HBCUs to preserve National Register listed buildings on their campuses <a href="https://go.nps.gov/hbcu">https://go.nps.gov/hbcu</a>
- Paul Bruhn Historic Revitalization Grants NOFO to be posted Dec 2021/Due early 2022
  Awarded as block grants to be <u>subgranted</u> to NRHP listed (and eligible) properties in rural communities for site preservation that will encourage economic development (\$200 \$750K). <a href="https://go.nps.gov/revitalization">https://go.nps.gov/revitalization</a>

#### Semi guincentennial

The semi quincentennial grant program supports grants to state-owned resources listed in the National Register related to the semiquincentennial or 250th anniversary of the declaration of independence in 2026. This grant program is currently being designed and executed.
